Our school services students in grades 9 and 10 for which an AYP status is not applicable.

The Academy of Public Leadership opened in the fall of 2009 with approximately one hundred and ten (110) ninth graders and is currently adding a grade level each year until we serve grades 9–12 in 2012. The Academy of Public Leadership incorporates the following: a rigorous, college-preparatory curriculum; distributed counseling and multiple support systems for students; a dedicated team of educators; continuous professional development; extended school day and school year; parental involvement; and continuous organizational improvement (including site-based management). These features have been identified by our lead partner, the Institute for Student Achievement, an intermediary organization with proven record in turning around impersonal, underachieving, large high schools. The Academy of Public Leadership (APL) is designed to develop leaders for the Cody/Rouge Community. At the core of APL's instructional framework is inquiry-based instruction, project based learning, and collaborative learning. The instructional framework will be used in all courses but most significantly in the advisory courses.

The term "Public" stands strongly and proudly in our name for a variety of reasons.

- ❖ APL is well aware that its community has undergone, and continues to undergo, significant cultural and socio-economic changes due to gentrification.

- ❖ Our mission is to represent and support the Cody Rouge community to our fullest potential, and in turn, rely on the community to work us as best it can.
- ❖ The manner in which our school is run also models the idea of “community.” APL and our families are not just partners in education. We are a community. The best model of educating and preparing our students for successful young adult life is through constant communication and collaboration between home and school.
- ❖ Families are automatically members of our student’s Advisory group, and invited to meet regularly as an Adult Advisory group to engage in workshops and discussion related to topics of parent importance.
- ❖ Families are invited four (4) formal times to meet with student’s Advisors and teachers to discuss academic and social progress.
- ❖ Families are encouraged to participate in the exhibition displays, project work, and advisory experiences of students.
- ❖ Families are encouraged to tutor and support/lead APL enrichment programming.
- ❖ Families have multiple opportunities for leadership and to support leadership.

State law requires that we also report additional information.

Process for assigning pupils to the school

During the 2009-2010 school year, students were required to live within the boundary of the school to which they were assigned.

During the 2010-2011 school year Open Enrollment Detroit Public Schools implemented the “Open Enrollment Initiative. This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The “Open Enrollment Initiative” does not apply to the Examination High Schools, or Application Schools. Parents may enroll their child (ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school. It should also be noted that transportation will not be provided for students who select a school outside of the boundary of their home school. Detroit Public Schools' Core Curriculum:

Consistent with the District academic plan, **Excellent Schools for Every Child**, there are aggressive plans to accelerate the rate of student achievement and to ensure that students graduate with the academic and social skills necessary for success in college and the workplace.

Specific curriculum actions include:

- *alignment of the curriculum, lessons planning and pacing calendars to national and state standards
- *ensuring that material and texts and supplemental resources and used in the classroom are directly linked to and with the grade expectations
- *defined grade level expectations to create alignment throughout the school
- * Administration and review of quarterly benchmark assessments for students in grades 3-12
- *use pre-intervention tools such as the Dynamic Indicator of Basic Early Literacy Skills (DIBLES) to assess language fluency for students on grades Prek-2 to ensure literacy foundation for reading success
- *use of the data (both formal and informal) to inform teaching strategies and professional development needs for staff, including but not limited to, teachers and administrators
- *focused professional development on the use of appropriate curriculum and teaching strategies, monitoring results and developing the interventions for re-teaching, as necessary
- *use technology (Learning Village/an on-line instructional management system) as a tool to manage instruction and teacher practice

Access to the Core Curriculum

The instructional strategies and grade level expectations are aligned to the state standards and the NAEP. This represents the core curriculum which is supported by the texts, materials, computer soft ware and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan **Excellent Schools for Every Child**. This plan serves as the framework for each school's academic achievement plan. The frequent monitoring of the implementation of these plans is conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.

The variances from the state plan can be found in the grade level expectations which are also aligned to the higher standards of NAEP.

A Summer Parent University is offered with classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center are a vehicle for parents and other community member to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an on line instructional management system)

Web updates and semi-annual progress reports are also a means to disseminate information to parents and community.

Detroit Public Schools Core Curriculum is currently under revision. Pacing Charts and Curriculum guided will be posted to the Academic Affairs page of our web-site in the near future.

*Use the technology portal for parents to view daily lessons and to communication with teachers.

*implement and follow through with the parent contracts.

*increase the Volunteer Reading Corps from approximately 5000 volunteers this year to 10,000 for next school year.

The Detroit Public Schools' Office of Research, Evaluation, Assessment and Accountability has developed a data collection system which has enabled the district to comply with the Annual Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher-Conferences.

- 1.0 Data from the PTC Forms represent "parent interactions" with teachers, per school, per card-marking.
- 2.0 Parent Interaction Definition: During Parent Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature—a parent may not sign for a student if they did not talk about that student.
- 3.0 For a variety of reasons, five (5) DPS schools are not included in the data collection count due to some school closures and non-return of Parent Teacher Conference Signature List Documents.
- 4.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least three (3) instances, the calculated percentages are in excess of 100%. In each instance, each of these three (3) schools is an elementary school with a large parent turnout at each of the four (4) required conferences. If during each conference one (1) parent with two (2) students enrolled in the school visited three

(3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
