For 2011-2012, Cooke Elementary School did not make AYP because:

**We did not meet the 90% attendance rate goal.**

- Attendance Rate for All Students 87.1%; Black 87.1% and Economically Disadvantaged 87.1%.

We are actively working to address our AYP issues. To maintain our proficiency in reading and mathematics, we will use our formative data sources to monitor student achievement. A Math Specialist will instruct our students in math. A Reading Specialist will instruct our students in reading. We will rigorously monitor our students' progress in reading and math to positively impact student achievement school-wide. Attendance will be closely monitored and parental support will be given to ensure that all students attend school daily.

## Parent Involvement

Our parents meet three (3) times a month. During the first meeting parents, take part in an in-service in which they develop strategies to help their children increase performance in the content areas of reading, math and science. The second meeting is a Title I meeting in which parents are involved in data analysis, comprehensive needs, and school improvement planning. The third meeting is the Local School Community Organization (LSCO) in which parents come together to address school concerns and formulate ideas, which will have a positive impact on student achievement. Additionally, parents have a parent's room in which they can meet, as needed, to strategize parent involvement activities and school-community outreach to help maintain and increase parental involvement within the school.

State law requires that we also report additional information.

## Process for Assigning Pupils to the School

During the 2011-2012 school year, Detroit Public Schools implemented the “Open Enrollment Initiative.” This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The “Open Enrollment Initiative” does not apply to the Examination High Schools, or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school. It should also be noted that transportation will not be provided for students who select a school outside of the boundary of their home school. “Open Enrollment Initiative” resources can be found on our website at:

## **Access to the Core Curriculum**

The instructional strategies and grade level expectations are aligned to the State standards and the NAEP. This represents the core curriculum, which is supported by the texts, materials, computer software and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan. This plan serves as the framework for each school's academic achievement plan.

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.

The variances from the State plan can be found in the grade level expectations, which are also aligned to the higher standards of NAEP.

A Summer Parent University is offered with classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center is a vehicle for parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an online instructional management system), Web updates and semi-annual progress reports are a means to disseminate information to parents and the community.

Detroit Public Schools Core Curriculum is currently under revision. Pacing Charts and Curriculum guides will be posted to the Division of Teaching and Learning under the Leadership page of our website in the near future.

The Detroit Public Schools' Office of Research, Evaluation, Assessment and Accountability has developed a data collection system which has enabled the District to comply with the Annual Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher Conferences.

- 1.0 Data from the PTC Forms represent “parent interactions” with teachers, per school, per card-marking.
- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences (and in some instances school open houses) Schools/Teachers are

advised to have each parent participant provide a parent signature—a parent may not sign for a student if they did not talk about that student.

3.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least seven (7) instances, the calculated percentages are in excess of 100%. In each instance, each of these seven (7) schools is an elementary school or a Foundation for Early Learners School with a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
