Our school does not receive an Adequate Yearly Progress Status. To ensure later school success, for our children, Beard Elementary School provides a caring environment designed to develop the physical, emotional, social, and cognitive skills of our children. Our early literacy curriculum helps to develop our children's pre-reading, language, vocabulary and numbers skills. We will continue to lay the foundation for our children's academic success in order to impact Adequate Yearly Progress.

#### **Parent Involvement**

Parental Involvement is important to our school community. Beard Elementary School has partnered with Southwest Solutions and the Harriet Taubman Center to help organize parent groups and community partners to create schools of excellence in Southwest Detroit schools. "Our Kids Come First" is an initiative for parents that was started to help maintain safe and clean schools, increase parental involvement and incorporate the "whole" family and their needs from child care to health care, etc. Beard Elementary School has monthly parent

## Process for Assigning Pupils to the School

During the 2011-2012 school year Detroit Public Schools implemented the “Open Enrollment Initiative.” This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The “Open Enrollment Initiative” does not apply to the Examination High Schools, or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school. ## School Description:

Beard Elementary School serves students ages 3½ to 5 years old. We give students an opportunity to become literate in both Spanish and English. The curriculum is designed to prepare students academically and socially. We have an Extended-Day Kindergarten Readiness Program and a Kindergarten Academy. We offer summer classes and children can participate in our choir, field trips and other activities. Every staff member has at least a master’s degree.

Consistent with the Detroit Public Schools Academic Plan for 2012-2013, there are aggressive plans to accelerate the rate of student achievement and to ensure that students graduate with the academic and social skills necessary for success in college and the workplace.

## **Access to the Core Curriculum**

The instructional strategies and grade level expectations are aligned to the State standards and the NAEP. This represents the core curriculum, which is supported by the texts, materials, computer software and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan. This plan serves as the framework for each school's academic achievement plan.

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.

The variances from the State plan can be found in the grade level expectations, which are also aligned to the higher standards of NAEP.

A Summer Parent University is offered with classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center is a vehicle for parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an online instructional management system), Web updates and semi-annual progress reports are also a means to disseminate information to parents and community.

Detroit Public Schools Core Curriculum is currently under revision. Pacing Charts and Curriculum guides will be posted to the Division of Teaching and Learning under the Leadership page of our web-site in the near future.

- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature—a parent may not sign for a student if they did not talk about that student.
  
- 3.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least seven (7) instances, the calculated percentages are in excess of 100%. In each instance, each of these seven (7) schools is an elementary school or a Foundation for Early Learners School with a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
