Annual Education Report (AER) Cover Letter (2012-2013)

Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2012-2013 educational progress for the Turning Point Academy. The AER addresses the complex reporting information required by Federal and State laws. The school's report contains information about student assessment, accountability and teacher quality. The State has identified some schools with the status of Reward, Focus or Priority. A Reward school is one that is outperforming other schools in achievement, growth, or is performing better than other schools with a similar student population. A Focus school is one that has a large achievement gap in 30% of its student achievement scores. A Priority school is one whose achievement and growth is in the lowest 5% of all schools in the State. Our school has not been given one of these labels.

The key challenges for our school are as follows:

We did not meet the 90% attendance rate goal.

- The attendance rate for the All Students subgroup is 71.4%.

We did not test 95% of our students.

- Only 82.35% of the All Students; 81.25% of the African American; 87.18% of the Economically Disadvantaged and 82.35% of the Students with Disabilities subgroups were assessed in reading.
- Only 82.35% of the All Students; 81.25% of the African American; 87.18% of the Economically Disadvantaged and 82.35% of the Students with Disabilities subgroups were assessed in mathematics.
- Only 68.75% of the All Students and 68.75% of the Students with Disabilities subgroups were assessed in science
- Only 66.67% of the All Students; 63.64% of the African American and 67.65% of the Students with Disabilities subgroups were assessed in social studies.

We did not attain Differentiated target achievement goals for all subgroups of students in reading.

- Only 16.67% of the All Students subgroup met the Differentiated target for reading.

We did not attain Differentiated target achievement goals for all subgroups of students in writing.

- Only 0.0% of the All Students subgroup met the Differentiated target for reading.

We did not attain Differentiated target achievement goals for all subgroups of students in science.

- Only 13.33% of the All Students subgroup met the Differentiated target for science.

We did not attain Differentiated target achievement goals for all subgroups of students in social studies.

- Only 4.35% of the All Students subgroup met the Differentiated target for social studies.

We are actively working to address our Michigan School Scorecard issues, accelerate student achievement and close persistent gaps in achievement. It is the desire of this school's administration and school improvement team to implement a data driven action plan base on research proven strategies to give math and science our immediate attention. Intense math workshops for teachers and solicit community members for in school tutoring in the subject of

math. It is our intent to increase the level of proficiency in math by 5% in the 2013-2014 school year for all students and grade levels.

Parent Involvement

Turning Point Academy will communicate the importance of testing to our parents. We will provide information to parents regarding the importance of test participation and the implication of nonparticipation for the child and his or her school. In parent meetings, parent teacher conferences, open house, intakes, or resource materials.

Turning Point Academy staff members will emphasize the critical roll testing now plays In Detroit Public Schools. We will include testing dates on our school calendars and newsletters. Students will be instructed to take pretest brochures home to share with their parents or guardians. We will also send emails and postcards to parents reminding them of the testing dates as they approach.

State law requires that we also report additional information.

Process for Assigning Pupils to the School

During the 2011-2012 school year, Detroit Public Schools implemented the “Open Enrollment Initiative.” This initiative allows students to elect to attend any Detroit Public School without being required to live within the boundary for that school. The “Open Enrollment Initiative” does not apply to the Examination High Schools or Application Schools. Parents may enroll their child(ren) in the school of their interest as long as the school has not reached capacity for their particular grade. Enrollment preference is given to students who live within the boundary of a school.

Access to the Core Curriculum

The instructional strategies and grade level expectations are aligned to the State standards and the NAEP. This represents the core curriculum, which is supported by the texts, materials, computer software and other school level resources used daily in the classrooms. All of the professional development activities are aligned to the core curriculum.

The implementation is a process delineated in the District Plan. This plan serves as the

framework for each school's academic achievement plan.

The frequent monitoring of the implementation of these plans are conducted by the school diagnostic visits, review of the benchmark assessments, use of the teacher evaluation tool and adherence to the pacing calendar.

The variances from the State Plan can be found in the grade level expectations, which are also aligned to the higher standards of NAEP.

Parents/Guardians are offered classes to increase parenting skills, early childhood literacy, adult literacy and GED. During the school year, the Regional Parent Resource Center is a vehicle for parents and other community members to participate in regular and on-going informational and participatory sessions focused on curriculum and instruction. Learning Village (an online instructional management system), Web updates and semi-annual progress reports are a means to disseminate achievement information to educators. h

The Detroit Public Schools' Office of Research, Evaluation, Assessment and Accountability has developed a data collection system which has enabled the District to comply with the Annual Education Report criteria of identifying the number and percent of students represented by parents at Parent-Teacher Conferences.

- 1.0 Data from the PTC Forms represent “parent interactions” with teachers, per school, per card marking.
- 2.0 Parent Interaction Definition: During Parent-Teacher Conferences (and in some instances school open houses) Schools/Teachers are advised to have each parent participant provide a parent signature-a parent may not sign for a student if they did not talk about that student.
- 3.0 Several DPS schools had a very high percentage of reported parent interactions. This may be due to a number of reasons. In at least seven (7) instances, the calculated percentages are in excess of 100%. In each instance, each of these seven (7) schools is an elementary school or a Foundation for Early Learners School with a large parent turnout at each of the required conferences. If during each conference, one (1) parent with two (2) students enrolled in the school visited three (3) teachers for each of their two (2) students, this would count as six (6) parent interactions, thus increasing the base number and resulting percentage.
